





Principles of Reception of Overseas Guests and Delegations and Preferential Offer of Booths by The Organizing Committee of the China International Fair for Investment and Trade (CIFIT)

In order to do well in the reception of important guests and delegations invited by China International Fair for Investment and Trade (CIFIT) and ensure their participation in exhibitions, the following working principles are hereby formulated for the reference and implementation by all relevant departments of ministries, provinces, and cities.

- I. Reception Principles for Overseas VIP Guests and Delegations
- (I) The six co-hosted international organizations of the CIFIT

The co-hosts of the CIFIT include: United Nations
Conference on Trade and Development (UNCTAD), United
Nations Industrial Development Organization (UNIDO), World
Trade Organization (WTO), Organization for Economic
Co-operation and Development (OECD), International Finance
Corp (IFC), World Association of Investment Promotion Agencies
(WAIPA).

1. The organizing committee provides the international

round-trip air tickets for two personnel from UNCTAD, UNIDO, WTO, OECD, IFCand WAIPA respectively (business class), among which the Director-General and the Secretary-General enjoy the courtesy of taking firstclass seats (with spouse acceptable).

- The Organizing Committee is responsible for the local transportation expenses in Xiamen of the participants and the board and lodging expenses for 2 persons of each organization for 4 nights.
- (1) The accommodation for the Director-General and the Secretary-General shall be arranged according to the standards of ministerial level, and deputy ministerial level for the Deputy Director-General and the Deputy Secretary-General. In principle, five-star hotels shall be arranged; if the accommodation exceeds 4 nights due to special circumstances, the organizing committee shall decide as appropriate;
- (2) The dedicated cars for the Director-General and the Secretary-General shall be arranged according to the standards of ministerial level, and the deputy ministerial level for the Deputy Director-General and the Deputy Secretary-General. Special personnel shall be arranged for full-time accompany;

(II) Other International Organizations

For other participating international organizations other than

the six co-hosting international organizations of CIFIT, the organizing committee shall determine the reception principles according to their actual situations.

(III) Government Delegations from Overseas Countries

- Government Delegations from Overseas Countries enjoy the following reception preferential principles:
- (1) For the government delegation led by the officials of president or premierlevel, the organizing committee shall bear the local transportation expenses of the delegation in Xiamen and the board and lodging expenses of 10 persons of the delegation for 4 nights.
- (2) For the government delegation led by the officials of vice president or vice premierlevel, the organizing committee shall bear the local transportation expenses of the delegation in Xiamen and the board and lodging expenses of 8 persons of the delegation for 4 nights.
- (3) For the government delegation led by the officials of ministerial level, the organizing committee shall bear the local transportation expenses of the delegation in Xiamen and the board and lodging expenses of 5 persons of the delegation for 4 nights.
- (4) For the government delegation led by the officials of deputy ministerial level, the organizing committee shall bear the

local transportation expenses of the delegation in Xiamen and the board and lodging expenses of 3 persons of the delegation for 4 nights.

- (5) For the government delegation led by the ambassadors to China, the organizing committee shall bear the transportation and board and lodging expenses during the participation in Xiamen inaccordancewithvice ministerial leveldelegation (three people, four nights). Diplomatic envoys of other levels to China need to bear the travel expenses on their own.
- (6) In principle, for theoverseas government delegation led by the officials of departmental level, the organizing committee only bear the local transportation expenses of the delegation in Xiamen.
- (7) The accommodation standard: hotels of four-star and above, and dedicated cars and personnel are arranged for full-time accompany.
- For overseas government delegations with special circumstances, the organizing committee and the inviting organization shall agree on the preferential reception standards separately.
- All overseas enterprise delegations (including those attendwith government delegations) participating in the CIFIT shall bear the expenses on their own during their stay in Xiamen.

II. Preferential Terms of Booth

- The organizing committee provides 18 square meters of free booths with basic decoration for each of the six co-hosts. If there are any further specific cooperation between the co-host and the organizing committee, the specific cooperation agreement shall be followed.
- 2. The organizing committee will give a 50% discount on the booth price to the Guest Country of Honor. If the Guest Country of Honor applies for more preferential treatment or discount, the organizing committee shall determine according to the actual situation.
- 3. The organizing committee will provide 18 square meters of free booths with basic decoration for the government agencies of overseas countries (regions) participating in the exhibition, and a 50% discount will be given according to the booth pricing standard for the excess area.
- 4. If other overseas official institutions or other international institutions apply for free booths, the organizing committee shall determine according to the actual situation, and give no more than 18 square meters of free booths with basic decoration.
- For the participating official government agencies or non-for-profit business associations, the maximum discount of 50% of the booth pricing standard will be given.
